**Parent and Family Engagement Policy**

Marti Elementary School believes that by partnering with parents we can offer rigorous and relevant learning to help educate all students and develop both academic and social skills.

**Title I regulations require that each school served under Title I jointly develop with and distribute to parents of participating children, a written parental involvement policy agreed on by the parents that describes the requirements outlined in Title I law.**

**A. POLICY INVOLVEMENT**

**1. Convene an annual meeting, at a convenient time, to which all parents of participating children shall be invited and encouraged to attend, to inform parents of their school's participation under this part and to explain the requirements of this part, and the right of the parents to be involved;**

Marti Elementary hosts an outdoor back-to-school event for families to meet the teachers. During this event, campus leaders explain programs and services available to students and their families. Parents are invited to an Open House to tour the classrooms and explore the learning environment. An annual Title 1 Meeting is offered in-person and virtually. The Title I program is explained and parent input is encouraged. Follow-up to this meeting includes the distribution of the Title I brochure and School/Parent Compact. The materials are also posted on the campus website.

**2. Offer a flexible number of meetings, such as meetings in the morning or evening, and may provide, with funds provided under this part, transportation, child care, or home visits, as such services relate to parental involvement;**

Monthly parent involvement opportunities are provided throughout the year. We offer a variety of programs and events to encourage parental involvement and strengthen the school-community relationship. Beginning in August, we host Meet the Teacher, Grandparents' Day Celebration, Book Fair (with both day and evening availability), musical performances (both day and evening), Veterans' Day celebrations (both day and evening), Christmas Event, Family Movie Nights, Curriculum Nights, End of Year Celebrations and Graduations, Parent Education

Events – Active Shooter Training, Internet and Social Media Safety, Emotional Support for Your Student – (both day and evening opportunities), and Field Trips.

**3. Involve parents, in an organized, ongoing, and timely way, in the planning, review, and improvement of programs under this part, including planning, review, and improvement of the school parental involvement policy;**

Marti Elementary is committed to frequent communication with family stakeholders concerning student learning. Ways in which the staff communicate with families include; Cleburne ISD website, Marti Elementary website, Marti Elementary Facebook, Backpack Mail, Closed Circuit TV in Lobby, Zoom meetings, Class Dojo, Canvas, Seesaw, Skyward Family Access, Elementary Student Handbook, Registration Packet, August Open House, Parent Conferences held every Fall, and Six Week Report Cards. Parents are also included on the campus site base committee that reviews campus goals, campus needs, future parent involvement activities, and the parent/school compact yearly.

**4. Provide parents of participating children timely information about programs under this part; descriptions and explanation of the curriculum in use at the school, the forms of academic assessment used to measure student progress and the proficiency levels students are expected to meet; and if requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any suggestions as soon as practically possible.**

Marti Elementary will provide to all parents the grade level requirements for its students. STAAR testing schedule and assessment goals are available on the district web page. A required parent conference for all parents is conducted during the fall semester. State assessment and year-long educational goals are discussed with parents. These conferences are offered in-person, by telephone, and Zoom to ensure all parents receive pertinent information concerning their child's progress. Additionally, parents are notified every three (3) weeks if a student is not mastering the specific coursework. Additional intervention and tutoring services are communicated to parents as well. Every six (6) weeks, report cards are distributed to parents. Skylert messages are sent to parents anytime that important information needs to reach parents. In addition, teachers have a daily conference period during which parents may request an individual meeting to discuss their child's progress. These appointments can be made by contacting the school office at 817-202-1650.

As a Title I campus, Marti Elementary consults with the Campus Site Base Committee to annually develop, review, and revise the school-parent compact. - 1. Marti elementary will hold an annual meeting during the fall semester of the new school year for all parents. At this meeting the Title I program requirements and guidelines will be discussed. Parent volunteers will be recruited to assist with various roles and responsibilities.

Since the goal of Marti Elementary is student success, the expectations for school performance, individual student assessments, and grade level curriculum will be provided in a format parents can understand. Translators will be available when needed.

Parents will be advised that the effectiveness of the Parent and Family Engagement Policy will be evaluated yearly and the policy will be revised to meet the needs of the students’ parents, and community.

- 2. Shall provide materials and training to help parents work with their children to improve their children's achievement, such as literacy training and using technology, as appropriate, to foster parental involvement;**

Marti Elementary values the partnership of parents in their children's education. There are many ways parents can make significant contributions to student success both at home and by volunteering at school. Student achievement is the result of effective home-school-community partnerships. Throughout the course of the year, the following capacity-building opportunities will be offered (these events are examples only, and should not be considered as all-inclusive):

- ARD, 504, and Intervention meetings;
- Family events such musical performances and book fairs;
- Campus Site base meetings.

Marti Elementary values its community and works diligently with our Family Liaison and VIPS (Volunteers in Public Schools) to bring programming into the schools and to the families.

In addition, staff professional development focuses not only on curriculum and instruction but on relationship building as well. Marti Elementary has been recognized as a National PTA School of Excellence for our community relationships and as a Capturing Kids' Hearts National Showcase Campus for our relational capacity with students and families.

- Use of interpreter to communicate with parents and staff

- Networking with area agencies who provide interpretation services as necessary.
